Invesco Markets II plc (the "Company")

This is to inform the Shareholders of various updates in one or more sub-funds of the Company listed in the Appendix (each a "Fund"):

1. Amendment to Dealing Deadlines;
2. The Minimum Equity Ratio for a number of Funds will be reduced from 85%, however a minimum continuous investment of more than 50% of their net asset value into equities will be maintained to qualify as an equity fund (as defined in section 2 paragraph 8 of the German Investment Tax Act). Investors should seek advice from their tax advisors on the implications of the German Investment Tax Act; and
3. Amendment to the investment policy to clarify FDI usage;

Details of these changes are further set out in the Appendix. These changes will be reflected in each of the relevant Supplements in due course and will be available to investors free of charge. Whilst the changes described above do not require Shareholder approval, should a Shareholder wish to redeem his/her shareholding, he/she may do so in accordance with the dealing provisions outlined in the Supplement or, for listed Funds, by selling the Shares on the relevant stock exchange.


