Re: Approval of Name Change of the Company and Corresponding Amendments to the Constitution of the Company

Dear Shareholder

This notice is to inform you that the Company has changed its name from Source Markets II plc to Invesco Markets II plc with effect from 30 May 2018. Shareholders voted in favour of the change of name and amendments to the Constitution of the Company to reflect the name change at an extraordinary general meeting held on 4 May 2018. Furthermore, there has been a renaming of all of the sub-funds of the Company, as outlined in Schedule 1. This change did not require Shareholder approval.

Please note that the LEI and ISINs of the Company and its sub-funds will remain unchanged.
