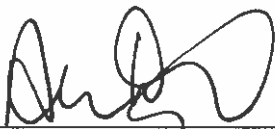
Dear Madams / Sirs

Pursuant to the provisions of the Decree 138, issued by the Italian Government on 13/11/2011 (article 2, paragraphs 6, 7, 13 and 14), hereby we certify the percentages of financial instruments held by our Funds, that will grant a reduced taxation rate in the period between 01 January 2013 and 30 June 2013. These percentages refer to the holdings in State Bonds of countries belonging to the Italian White List and will be subject to a tax reduction, by means of a limited participation, to the extent of 62,5% to the total profits realized by your Italian resident clients, through direct or indirect investments.

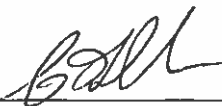
