Invesco Solar Energy UCITS ETF (the "Fund") A sub-fund of Invesco Markets II plc (the "Umbrella Fund") Acc (ISIN: IE00BM8QRZ79) (the "Share Class")

The Fund is managed by Invesco Investment Management Limited, part of the Invesco Group.

Objectives and Investment Policy

- The Fund is a passively-managed Exchange-Traded Fund (ETF), which aims to track the net total return performance of the MAC Global Solar Energy Index (the "Index")¹, less fees, expenses and transaction costs.
- To achieve the investment objective the Fund will, as far as possible and practicable, hold all the securities in the Index in their respective weightings.
- The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances investors will be permitted to redeem their shares directly from Invesco Markets II plc in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.
- The Fund is an Article 8 Fund (it promotes environmental and/or social characteristics) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainabilityrelated disclosures in the financial services sector ("SFDR").
- The Fund's base currency is USD
- Dividend Policy: This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.
- Net Asset Value: This is calculated daily and the Fund is open for subscriptions and redemptions on each day the United States Federal Reserve System is open. Please refer to the prospectus for further information.
- The Index: The Index is a thematic index which is designed to reflect the performance of the global solar energy equity sector. Companies will be excluded from the index in accordance with the ESG criteria of the index methodology: 1) if they are deemed by the Index provider to be involved in certain business activities; or 2) the company has an S&P Governance and Economic Score of less than 5; or 3) the company has no S&P Governance and Economic Score coverage. Companies are deemed eligible for inclusion if they derive significant revenue from the following business segments of the solar industry: solar power equipment producers; suppliers of raw materials, components or services to solar producers or developers; companies that produce solar equipment fabrication systems; companies involved in solar power system installation, development, integration, maintenance, or finance; companies that produce hydrogen using solar energy; companies that provide solar-powered charging systems for electric vehicles or other electrical devices; companies selling systems that use solar thermal energy to produce heat or electricity; companies that sell electricity derived from solar power. All the companies eligible for inclusion in the Reference Index are analyzed to determine whether solar power is a significant component of a company's business. The index universe is defined by the index provider conducting bottom-up industry research to identify eligible companies and define their level of exposure to the solar industry. Securities must also meet certain liquidity and tradability criteria to be eligible for inclusion in the Index. The index is weighted by level of exposure to the solar industry and free-float market capitalisation. The Index is rebalanced quarterly.

Other Risks


- General Investment Risk: The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- Emerging market risk: Emerging markets are generally more sensitive to economic and political conditions and less liquid than developed markets.

- Sector concentration risk: As this Fund has significant exposure to one or a small number of sectors, investors should be prepared to accept a higher degree of risk than for a fund with a broader investment mandate.
- Holdings concentration risk: The Fund might be exposed to a limited number of
 positions which might result in greater fluctuations in the value of the Fund than for a
 fund that is more diversified.

- *Currently, the Fund is not exercising its entitlement to apply entry and exit charges.
- The **ongoing charge** is based on the fee paid to the Manager. The Manager is responsible for discharging from its fee, costs attributable to the Investment Manager, Administrator, Depositary as well as the Operational Expenses incurred by the Fund. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- Because the Fund is an ETF, investors will typically only be able to buy or sell shares in the secondary market. Accordingly, investors may incur brokerage and / or transaction fees in connection with their dealings. Investors may also bear the costs of "bid-ask" spreads; meaning the difference between the prices at which shares can be bought and sold. You should discuss these fees and costs with your broker before you invest, as they may reduce the amount of your initial investment and the amount you receive on disposal.
