Moreover, issue and redemption prices, together with the interim profit and the aggregate amount of income deemed to have been received by the holder of foreign investment units after 31 December 1993, are published on the section dedicated to German investors of the website eff.invesco.com.
5. In addition to a publication on the section dedicated to German investors of the website eff.invesco.com, Shareholders will be informed via shareholder letter about the following changes:
 - the suspension of redemption of a Fund's Shares;
 - the termination of the management of a Fund or the liquidation thereof,
 - changes being made to the Constitution of the Company or the Prospectus (including the Supplements) which are not in compliance with the existing investment principles or changes which affect material investor rights or which relate to fees and cost refunds that may be withdrawn from a Fund;
 - the merger of a Fund; and,
 - where relevant, the conversion of a Fund into a feeder fund and a change of a master.
