The Company has changed its name from Source Physical Markets Plc to Invesco Physical Markets Plc with effect from 27 March 2018. The Company has also changed the names of each of the precious metals series issued by the Company, the names of which can be found at Schedule 1.

The Company's constitutional document has also been amended to reflect the change of name described above and compliance with the Irish Companies Act. Trustee consent has been granted to the Company to effect these changes.

Please note that the LEI and ISINs of the Company and precious metals series will remain unchanged.
