## **Description of Material**

London Good Delivery, Platinum Bars said to be purity 99.95% minimum, up to and including 99.99%, held to the order of the above client account.

## Audit Procedure

Over the course of the inspection a full count of 288 bars was carried out based upon the Custodian's platinum inventory as at close of business, (C.O.B.) 30<sup>th</sup> December 2022.

Each individual platinum bar in the platinum count was agreed to the records of the Custodian as being held in the name of the above-mentioned account. Each bar was then physically verified as correct through year of manufacture, serial number, refiner brand and purity, versus inventory reports supplied by the Custodian as at C.O.B. 30<sup>th</sup> December 2022. A 2.5 percent minimum random sample, (12 bars) was selected for check weighing.
