## NOTICE TO SHAREHOLDERS

Dear Shareholder,

We are writing to you as a Shareholder of Invesco Commodity Composite UCITS ETF, ISIN IE00B4TXPP71, (the "**Fund**"), a sub-fund of Invesco Markets Public Limited Company (the "**Company**"), to inform you of an upcoming change to the Solactive Commodity Composite Index (the "**Reference Index**").

In accordance with the rules and methodologies of the Reference Index, Solactive AG, as index sponsor, is replacing a constituent index of the Reference Index as follows: the Morgan Stanley MSCY Radar F3 Roll Index TR is being replaced with the Credit Suisse Custom 66-01E Total Return Index (the "**New CS Constituent Index**").

The New CS Constituent Index is a long only index which utilises the components and the methodology of the Bloomberg Commodity Index Excess Return, and re-defines the hedge roll period. For each month except January, the New CS Constituent Index features the following roll period: first roll date is the fifth index business day prior to the last index business day of the previous month. Last roll date is the fourth index business day of the month. The index rolls at an actual roll percentage of 10%. The New CS Constituent Index features a custom roll schedule, with two contracts per index component per calendar year only.

### Notice Period and Effective Date

It is expected that the changes will be effective from on or around the close of business on 15 June 2022 (the "**Effective Date**"). The changes will be reflected in the supplement of the Fund (the "**Supplement**") and will be available to investors free of charge.

Should you wish to redeem your shareholding, you may do so in accordance with the dealing provisions outlined in the Supplement.


