Invesco PowerShares - Changes to ETF product line up reminder

Dear Market Participant,

As part of our firm's commitment to aligning its fund offerings to meet an evolving investment landscape, Invesco PowerShares announced at the end of last year that it will close 5 funds from its current UCITS range of ETFs. The ETFs are scheduled to close on 10 March 2016. These closures will enable Invesco PowerShares to better align its product line with client demand and allow the firm to continue to introduce ETF solutions that seek to meet investor needs going forward.

The changes have been reviewed and approved by the Directors of the fund governance board as appropriate and in the best interest of fund shareholders, given current size of the funds and investor demand. Fund shareholders will have already received a closure notice.

Therefore, as a reminder, the following funds will be liquidated on 10 March 2016 with the last day of trading to be 8 March 2016:
